# PRIVACY POLICY AGREEMENT

#### 1. General Provisions

1.1. This Privacy Policy Agreement (hereinafter referred to as the "Agreement") applies to all information that Radli47 (hereinafter referred to as the "Operator") may obtain about the User during the use of the Operator's website, services, programs, and products (hereinafter referred to as the "Services"). It governs the relationship between the Operator and the User throughout the entire period of service provision and User access to the personalized services of the website.

1.2. Terms and Definitions

The following terms are used in this Agreement:

• User: Any individual who voluntarily registers on the website and receives a unique authorization code to use the website's Services.

- Personal Data Operator: Radli47.
- Website: The online resource with the domain address radli47.com.
- Website Services: All services available for User utilization on the website.
- Personal Information: Information provided by the User about themselves during

registration (account creation) or while using the Services, including but not limited to personal data.

• Personal Space: A personalized website interface with user tools for accessing personalized Services.

## 2. Purposes of Collecting and Processing User Personal Information

2.1. The Operator collects, records, stores, processes, updates, uses, distributes, anonymizes, and destroys User personal information, including through automated systems, as necessary to provide the website's services.

2.2. The User's personal information is used by the Operator for the following purposes:

2.2.1. Providing effective customer support.

2.2.2. Delivering personalized Services.

2.2.3. Communicating with the User, including sending notifications, requests, and information related to the use of the Services, as well as processing User inquiries and applications.

2.2.4. Improving the quality and usability of Services and developing new Services.

2.2.5. Providing information about the Operator's services, responding to inquiries, and fulfilling the Operator's obligations to service consumers.

2.2.6. Conducting statistical and other research based on anonymized data.

2.2.7. Sending messages to the User.

2.3. The Operator does not verify the accuracy of personal information provided by the User and does not monitor its relevance. However, the Operator assumes the information provided during

registration is accurate and current. The User is solely responsible for providing inaccurate or outdated personal information and bears the consequences thereof.

# 3. Conditions for Processing and Transferring User Personal Information to Third Parties

3.1. The Operator stores and processes User personal information in compliance with applicable legal regulations and internal policies based on them (e.g., name, email, gender, birth date, postal address, phone numbers, etc.).

3.2. Personal information confidentiality is maintained except when voluntarily disclosed by the User for public access.

3.3. The Operator protects User personal information according to applicable security requirements and employs safe methods for safeguarding such information.

3.4. To protect personal information, ensure its proper use, and prevent unauthorized or accidental access, the Operator implements appropriate technical and administrative measures. User-provided personal information is stored on restricted-access servers located in secured facilities.

3.5. The Operator may transfer User personal information to third parties (including those responsible for processing, storing, updating, or destroying personal data) in the following cases:3.5.1. The User has consented to the processing of their personal data by checking the "I agree to the processing of my personal data" box when filling out forms on the website.3.5.2. The transfer is necessary for the use of specific website Services.

## 4. Procedure for Changing Personal Information by the User

4.1. The User can modify (update, supplement) their personal information or its confidentiality settings in the personal section of their account at any time.

4.2. The User may request the deletion of their personal information by contacting the Operator's customer support at info@radli47.com.

4.3. The User may opt out of receiving newsletters by clicking the unsubscribe link at the bottom of any email.

## 5. Agreement Confirmation

5.1. If any condition of this Agreement is unacceptable, the User may decline to confirm the Agreement.

5.2. By accepting this Agreement (clicking the "I Accept the Privacy Policy Agreement" button), the User fully agrees with all its terms. The User also consents to receiving information about special offers and new services via electronic communication and the processing of their personal data, including transfer to third parties, as specified in this Agreement.

5.3. The User's consent is valid for five years and is automatically renewed unless revoked.

5.4. Processing personal data without User consent is only permitted in cases prescribed by law in the interests of national security, economic welfare, or human rights.

#### 6. Changes to the Privacy Policy Agreement

6.1. The Operator reserves the right to amend this Agreement. The updated Agreement will indicate the date of the latest revision and become effective upon publication on the website unless stated otherwise.
